Swarf fires - Neat metal working oils may fume, thermally decompose or ignite if they come into contact with red hot swarf. Protective measures

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Do not get in eyes or on skin or clothing. Do not ingest. Avoid breathing vapor or mist.
