

# Section 4. First aid measures

### **Description of necessary first aid measures**

**Eye contact**

# Section 8. Exposure controls/personal protection

Appropriate engineering controls

: Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

Conclusion/Summary

: Distillates (petroleum), hydrotreated heavy naphthenic: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects. Dec-1-ene, homopolymer, hydrogenated Dec-1-ene, oligomers, hydrogenated: Practically non-irritating to eyes. Practically non-irritating to the skin.
