1,2-Benzenedicarboxylic acid, di-C9-11-branched alkyl esters, C10-rich: A 2-generation reproductive toxicity study conducted on this material did not identify any effects on reproductive parameters. However, the study did identify a small increase in early offspring mortality at the high oral dose level. Based on studies with laboratory animals, oral maternal exposure to this component can result in developmental toxicity to the conceptus.
