#### **Conclusion/Summary**

Distillates (petroleum), hydrotreated heavy paraffinic: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects. Phenol, 2,2'-polythiobis[4-C8-30-alkyl derivs., calcium salts, overbased: In subchronic feeding studies with calcium branched alkyl phenate sulfide, effects on reproduction were observed in experimental animals when residual alkyl phenol and its calcium salt were present at combined concentrations of 1.68% by weight or greater. No adverse reproductive effects were observed in a reproduction study of two finished lubrication oils contain 5% and 25 % of this material although male body weight was reduced. Also, data from 28 day subchronic studies of similar chemicals indicate potential induction of liver effects in rats characterized by necrosis and fibrosis at oral doses of 250 mg/kg/day or higher. In a combined four-week repeated dose oral toxicity, neurotoxicity and reproductive toxicity screen study in rats at 50, 300, and 1000 mg/kg/ day, body weight gain was decreased. Also, there were adrenal changes in males at 1000 mg/kg/day and serum cholesterol was decreased in males at 300 mg/kg/day and above.
