

Description of necessary first aid measures

Section 5. Fire-fighting measures

Specific hazards arising from the chemical

Section 6. Accidental release measures

Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Precautions for safe handling

: Distillates (petroleum), solvent-refined heavy paraffinic: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects. Distillates (petroleum), hydrotreated light: Mineral spirits have produced slight to moderate skin irritation particularly with evaporation from the skin is prevented. Animal studies have demonstrated that mineral spirits produced mild respiratory tract irritation at elevated concentrations. The most common effects observed in repeated dose animal studies with mineral spirits are kidney changes that are consistent with an alpha 2u-globulin- mediated process that is not regarded as relevant to humans. Certain studies have reported effects in the liver as well as hematological or urine chemistry changes. Abuse of similar materials has been associated with irregular heart rhythms and cardiac arrest. In certain repeated dose animal studies have changes were reported in behavior, neurochemistry and sensory evoked potentials which may be irreversible. Repeated exposure to elevated concentrations of hydrocarbon solvents can produce a variety of transient CNS effects (e.g., dizziness, headache, narcosis, etc).
