- Shell Rotella® DEF meets all ISO 22241 for aqueous urea solutions (AUS 32) used in diesel engine SCR emission systems.

- The high purity and low ash content of Shell Rotella® DEF helps to protect the SCR system.
- Shell Rotella® DEF is provided in convenient packaging with a pour spout included and may be used in all diesel SCR emission systems equipped with diesel exhaust fluid injection for NOx reduction.

Main Applications

Shell Rotella® DEF is for use in all diesel emission systems requiring ISO 22241 (AUS 32) or API DEF certification. Used in conjunction with the SCR catalyst for removal of NOx emissions in some passenger cars as early as model year 2008, light and commercial trucks from 2010, and offroad and stationary diesel engines from 2011 where required for proper vehicle operation.
